

#### TERMS AND CONDITIONS FOR KFH LIBSHARA ACCOUNT-i DRAWS CAMPAIGN ("CAMPAIGN")

KFH Libshara Account-i is protected by PIDM up to RM250,000 for each depositor.

#### 1. Campaign Period

- 1.1. This KFH Draws Campaign ("Campaign") is organised by Kuwait Finance House (Malaysia) Berhad ("KFH Malaysia") and will commence from 00:00 hours (GMT+8) on 1 April 2024 until 23:59 (GMT+8) hours on 31 March 2025 (both dates inclusive) ("Campaign Period").
- 1.2. KFH Malaysia reserves its right and discretion to vary or amend the Campaign Period at any time with prior notice, without assigning any reason whatsoever.
