

KFH DEBIT CARD-i 10.10 SPEND & WIN ! CAMPAIGN's Frequently Asked Questions (FAQs)

CAMPAIGN BACKGROUND

1. What is KFH Debit Card-i 10.10 Spend & Win ! Campaign all about?

The KFH Debit Card-i 10.10 Spend & Win! Campaign (“This Campaign”) offers Cardholders a chance to win Cash Prizes worth up to RM1,000. Cardholders need only to perform a purchase transaction (Contact, Contactless and E-Commerce) using KFH Debit Card-i during the Campaign Period.

2. What is the Campaign period?

This Campaign commences at 00:00 on 10 October 2022 until 23:59 on 10 November 2022, inclusive of both dates (“Campaign Period”).

3. Who is eligible to participate?

This Campaign is open to all new and existing Principal and Supplementary cardholders holding a KFH Debit Card-i card issued by KFH Malaysia except the following:

- i. Campaign Organizers (eChannel Development & Cards Department)
- ii. Those KFH Malaysia Savings Account-i or KFH Malaysia Current Account-i (“CASA-i”) which have been terminated voluntarily or by involuntarily cancelled during the Campaign Period.
- iii. Inactive Cards

4. Is prior registration required?

No, you are not required to enroll or register for This Campaign.

PARTICIPATION CRITERIA

5. What is the minimum spending criteria in order to participate?

Participation is simple. Eligible Cardholders need only to perform the transactions at merchant outlets or eCommerce website to entitle for campaign entry as below:

Qualifying Criteria	Campaign Entry
Every transaction spent with KFH Debit Card-i with no minimum amount	1

Example:

Total number of purchase transaction with KFH Debit Card-i	Campaign Entry
5 transactions of any amount	5 entries
10 transactions of any amount	10 entries

6. Is there a minimum amount to be made?

No, there is no minimum amount per transaction and you will be entitled for 1 campaign entry.

WINNER SELECTION

7. What are the prizes to be won under this Campaign?

This Campaign offers only one category for Prizes:

Prizes	Total Winners
RM1000	30 Winners

8. How will the winners be selected?

- i. The winners will be selected via Lucky Draw mechanism.
- ii. The shortlisted winners will then be required to answer one (1) challenge question correctly before being declared as a campaign winner.
- iii. Shortlisted Winners will be contacted by the Bank on the best effort basis in order to be deemed as the official winner.
